The Tech Fair Winners' Presentations' session will take place on Saturday 9 March at 11:30-13:00 in Hall H. Support from pharmaceutical partners helps make this event possible. The Human Medicine Regulations 2012, (clauses 294-300) and the European Union directive (2001/83/EC, article 86) provide guidelines relating to medicinal products for human use. Within these guidelines is the restriction that access to pharmaceutical product marketing activities must be limited to only those participants licensed / authorised to prescribe or supply medicinal products.

All participants, with the exception of the exhibitors, are asked the following question during registration: Are you licensed / authorised to prescribe or supply prescription only medicines? All event activities (including educational sessions, meal functions, exhibit hall, etc.) are exclusively reserved for registered attendees. Non-registered guests (including children, family members, colleagues, etc.) are not allowed in any of the event areas. Badges provided at registration are required for entrance into all functions and will be strictly enforced.
